Societatea Nationala Nuclearelectrica S.A. (“SNN”) informs its shareholders and investors that, based on the order to open negotiated interest rate deposit, on 27.11.2020, SN Nuclearelectrica SA placed with CEC BANK S.A. a deposit in the amount of 83.350.000 lei, with maturity date on 29.11.2021.

The percentage interest rate that applies to the above mentioned term deposits is of 2.40 % /year. We specify the fact that, on 27.11.2020, SNN has constituted deposits with CEC BANK SA, in the cumulated value of 551.794.000 lei (Appendix no. 1), the amount exceeding 5% of the value of SNN's net assets, as well as 10 % of the net turnover related to the last annual financial statement, reason for which, in accordance with the provisions of art. 92, index 3 of Law 24/2017 with subsequent amendments and completions and with the provisions of art. 234 letter i) of the ASF Regulation no. 5/2018, SNN has the obligation to report including the cumulative value of these transactions.
