**Decision of the Board of Directors regarding the distribution of dividends related to the financial year concluded on 31.12.2021**

In accordance with the current report issued to the capital market institutions on 25.03.2022, SN Nuclearelectrica SA («SNN») informs the shareholders and investors that based on the provisions of art. IV paragraph (2) of GEO no. 3/2022 corroborated with the provisions of the GD no. 404/25.03.2022 regarding the approval of the distribution to the state budget, for the financial year 2021, in the form of dividends, of a share of 50% of the accounting profit of Societatea Nationala Nuclearelectrica S.A. after deducting the profit tax, published in the Official Gazette on 25.03.2022, the Board of Directors approved on 28.03.2022 the dividend distribution proposal related to the financial year ended on 31.12.2021 which provides “the distribution to the state budget for the financial year 2021, in the form of dividends, of a share of 50% of the accounting profit of Societatea Nationala Nuclearelectrica SA remaining after deducting the profit tax ”(sole article of GD no. 404/25.03.2022).

Thus, based on the Decision of the Board of Directors dated 28.03.2022, **the value of the gross dividends** related to the financial year ended on 31.12.2021 is **595,925,367 lei**.

The net profit for the financial year is 1,036,261,626 lei. The profit remaining to be distributed after the deductions from the net profit of the financial year is 976,926,831 Lei.
