SN Nuclearelectrica SA ("SNN") informs the shareholders and investors that, on 20.05.2022, SNN's Board of Directors took note of the rightful termination of the Mandate Contract of Mr. Serban Constantin Valeca as result of his death, based on the provisions of the Mandate Contract concluded with the company on 28.04.2022.

Mr. Serban Constantin Valeca was appointed member of the Board of Directors of SNN, with a mandate contract, based on the provisions of GEO 109/2011, by the Decision of the General Meeting of Shareholders no. 5 / 28.04.2022.

Mr. Serban Constantin Valeca was a doctor of industrial sciences and a university professor with 40 years of experience in the nuclear industry, being General Director for the coordination of the national nuclear program Cernavoda NPP Unit 2, Governor of Romania at the International Atomic Energy Agency in Vienna and President of the Scientific Council of the ICN Pitesti Nuclear Research Institute. Mr. Serban Constantin Valeca was the author of specialized publications, research reports and held patents.
