Societatea Nationala Nuclearelectrica S.A. ("SNN") informs its shareholders and investors about the conclusion on 28.12.2022 of a legal act with the Romanian Electricity and Natural Gas Market Operator.

We specify that the value of the contract concluded with the Romanian Electricity and Natural Gas Market Operator, by SNN as seller, exceeds 5% of the value of SNN's net assets as per the most recent financial report as well as 10% of the net turnover as per the last annual financial statements, which is why, in accordance with the provisions of Article 108 of Law 24/2017 as amended and supplemented and the provisions of Article 234 letter i) of FSA Regulation no. 5/2018, SNN is obliged to report the value of this transaction.
