Societatea Nationala Nuclearelectrica S.A. ("SNN") informs shareholders and investors about the conclusion on 27.04.2023 of a legal deed with the Romanian Electricity and Gas Market Operator.

We specify that the value of the contract concluded with the Romanian Electricity and Gas Market Operator by SNN, as seller, exceeds 5% of the value of the net assets of SNN related to the latest financial reporting, as well as 10% of the net turnover related to the latest annual financial statements, reason for which, in accordance with the provisions of Article 108 of Law 24/2017, as subsequently amended and supplemented and with the provisions of Article 234 letter i) of the ASF Regulation no. 5/2018, SNN has the obligation to report the value of this transaction as well.
