

## **NICOLAE BOGDAN CODRUT STANESCU**

### **RESUME**

Mr. Bogdan Stanescu is currently the General Manager of the Commercial Entities Division within the Ministry of Energy, Small and Medium Sized Enterprises and Business Environment responsible for the coordination of the administrative activities of the companies in the Ministry's portfolio, including the participation in privatization commissions of IPP and IPO types and the drafting of the legal documents issued by the Ministry.

During 2010-2013, Mr. Bogdan Stanescu was counsellor to the Vice Governor of the Romanian National Bank, respectively the personal counselor of the Ministry of Economy, being responsible for advising on legal matters and coordination of the legal activity, drafting and approval of the legal documents.

During 2001-2010, Mr. Bogdan Stanescu occupied several management positions and legal advisory positions within APAPS and subsequently in AVAS (The Authority for the Capitalization of the State's Assets), thus coordinating the entire legal activity in the field of privatization, post privatization and the administration of the commercial entities in the AVAS portfolio.

Mr. Bogdan Stanescu has a relevant experience in the administration of public companies before and after privatization, with a focus on legal, analytical and administrative aspects of public companies.

Mr. Bogdan Stanescu is a fluent English and French speaker.
