**Information on the legal action initiated by Societatea Nationala Nuclearelectrica S.A. against the Regulatory Authority for Energy**

Societatea Nationala Nuclearelectrica S.A. ("SNN") informs its shareholders and investors that the petition to sue registered by SNN with the Bucharest Court of Appeal, under number 416/2/2014, against the Regulatory Authority for Energy ("ANRE") claiming the partial annulment of the Decision of the president of ANRE number 3906/20.12.2013 regarding the approval of the energy quantities sold based on regulated contracts and of the regulated prices for the energy delivered by SNN in 2014 as well the issuance of a Decision amended to include in the regulated tariff all the elements required and argued by SNN, which were not considered by ANRE, was overruled as ungrounded on 14.10.2014.

The Decision of the Bucharest Court of Appeal can be appealed against within 15 days after the notification.

We state the fact that, in compliance with the information presented by SNN in the current report dated 23.06.2014, as per Decision number 1408/18.06.2014, ANRE modified, starting July 1<sup>st</sup> 2014, the applicable prices for the regulated contracts concluded by SNN.

At the same time, based on the provisions of art. 11, letter c) item iii from the Methodology approved by Order number 83/20.11.2013, with the amendments from Oder number 36/17.06.2014, SNN will require ANRE to admit the costs uncovered in 2014, generated by the tax on special constructions stipulated by the Government's Emergency Ordinance number 102/2013.
