## Important event to be reported:

The update of the Revenues and Expenses Budget indicators for the financial year 2014

Societatea Nationala Nuclearelectrica S.A. ("SNN") informs the public and the shareholders that, during the Board of Directors held on September 15th, 2014, the update of the Revenues and expenses Budget indicators for the year 2014 was approved, as presented in Appendix 1.

The estimated gross profit is of 124.271 thousand lei (+213,5% compared to the Budget approved by the resolution of the OGMS number 5/31.07.2014), and the estimated net profit is of 98.998 thousand lei (+254,8% compared to the Budget approved by the resolution of the OGMS number 5/31.07.2014).

The total revenues estimate an increase of 89.737 thousand lei (+4,92 %), determined mainly by:

- The estimated sales of electricity based on the results achieved during the first 7 months of the year 2014 and the contracts concluded until the end of August 2014, both on the competitive and on the regulated market;
- The increase of the transport tariff for the electricity billed to the customers, from 10.02 lei/MWh to 10.32 lei/MWh, starting with 01.07.2014, in compliance with the Order of ANRE number 51/26.06.2014. The increase of this category of revenues is compensated by the corresponding increase of the cost of energy transport presented at "Expenses for goods and services" position (row 9);



- The increase of financial revenues generated mainly by the revenues from the foreign currency exchange rate differences recorded in the first semester of 2014 which were larger than the ones provided for the entire year 2014.

The total expenses estimate an increase of 5.104 thousand lei (+0,29%), mainly due to:

- The reduction of the tax on special constructions, through recalculation, following their revaluation in March 2014 and the reflection of the revaluation results through the net method at 31.12.2013;
- The increase of the amortization value following the process of the revaluation of the assets.

At the same time, a series of reclassifications and reallocations were performed in the structure.
