## Important events to be reported:

Information regarding the litigation initiated by S.C. Fondul Proprietatea S. A. related to the Resolution No.1/11 March 2014 of the Extraordinary General Meeting of Shareholders (EGMS).

Societatea Nationala Nuclearelectrica S. A. ("SNN") informs the shareholders that:

- 1) the legal action registered under no. 9853/3/2014 on the list of cases of the Bucharest Law Court by S.C. Fondul Proprietatea S.A., as a shareholder holding 9.7268% of the share capital of the company, whereby it requested the rejection of the petition for the registration with the Trade Office Register of EGMS's Resolution No.1/11 March 2014, was dismissed as unfounded. S.C. Fondul Proprietatea S.A. can appeal against this solution within 30 days after the communication.
- 2) the injunctive action registered under no. 11666/3/2014 on the case list of the Bucharest Law

Court by S.C. Fondul Proprietatea S.A., as a shareholder holding 9.7268% of the share capital of the company, whereby it requested the suspension of the application of the provisions of EGMS's Resolution No.1/11March 2014 EGM, was dismissed as unfounded. S.C. Fondul Proprietatea S.A. appealed against this solution.

By the Resolution of SNN's EGMS of 11 March 2014 the following have been approved:

- (i) SNN's participation in the share capital increase of Hidro Tarnita SA by subscribing a number of 89,000 newly issued shares, of a nominal value of 100 lei, issued by the company Hidro Tarnita SA;
- (ii) introducing in the draft budget of income and expenditure for the year 2014 the amounts required to be paid for the subscribed shares;
- (iii) the agreement, in principle, on the Romania -Turkey submarine cable interconnection project;
- (iv) SNN's participation in setting up "HVDCC Romania Turkey" project company by subscription and payment of the equivalent amount in lei of a total number of 2,000,000 shares with a nominal value of 1 euro.
