**The signing of an electric power sale-purchase contract by S. N. Nuclearelectrica S.A. and S.C. GEN-I, Bucharest-Electricity Trading and Sales S.R.L.**

Societatea Nationala Nuclearelectrica S.A. ("SNN") informs the shareholders that it signed an electric power sale-purchase contract with the trading company S.C. GEN-I, Bucharest-Electricity Trading and Sales S.R.L.. The contract was signed after an auction organized by OPCOM on the Centralized Market of Bilateral Contracts- CMBC for the sale offer, SN\_NCL \_ 427, submitted by SNN. The contract was concluded on the date of 20.03.2014.

The object of the contract is the sale of electric power by SNN and buying of electric power by S.C. GEN-I S.R.L.. The delivery of electric power provided by the contract will occur between 28.03.2014-31.03.2016, at a steady power of 130 MW, totaling an amount of 2,293,070.00 MWh. The total value of the transaction amounts to 381,039,442.00 lei in compliance with the auction closing price of 166.17 euro/MWh.

SNN and S.C. GEN-I S.R.L. have no mutual debt to each other on the contract signing date.

Payment term and methods: the payment shall be carried out monthly, in advance, two calendar days before the beginning of the month of delivery.
