A sale–purchase contract concluded between S. N. Nuclearelectrica S.A. and S.C. Electrica Furnizare S.A.

Societatea Nationala Nuclearelectrica S.A. (“SNN”) informs the shareholders that it concluded a contract with Societatea Comerciala Electrica SA, a company which is controlled by the Romanian State that is the majority shareholder of SNN. The contract was concluded as a result of an auction organized by OPCOM, on the Centralized Market of Bilateral Electric Power Contracts – CMBEC for a sale offer, SN_NCL_297, submitted to SNN. Following the auction organized as per the CMBEC regulations, the contract was awarded to SC Electrica Furnizare SA.

The contract was concluded on 13.11.2013.

The object of the contract is the electric power sale by SNN and electric power purchase by SC Electrica Furnizare SA. The electric power delivery will take place between 01.01.2014-31.12.2014, at a steady capacity , amounting to 262,800 MWh.

The total value of the transaction is of 45,467,028 lei corresponding to the auction concluding price of 173,01 lei/MWh.

SNN and SC Electrica Furnizare SA have no mutual debts on the contract concluding date.
