Societatea Nationala Nuclearelectrica S.A. (“SNN”) informs the shareholders and investors on the publishing of the Quarterly Report for the 3rd Quarter of the 2015 financial year, prepared in compliance with the provisions of art. 227 of Law no. 297/2004 and with Appendix no. 30 of the Regulation of the Romanian National Securities Commission no. 1/2006.

The Quarterly Report comprises:

- The main events in the company’s activity throughout the reporting period;
- The Quarterly Report of the Board of Directors for the nine month period ended on September 30, 2015;
- The Interim Individual Condensed Unaudited Financial statements as at and for the nine month period ended on September 30, 2015.

The main results

Within the nine month period ended on September 30, 2015, SNN registered a net profit of **131.189 mii lei**, 70% higher than the net profit of **77.291 mii lei** registered in the same period of 2014, EBITDA registered an increase of **9%**, while EBIT a **26%** increase, compared to the same period of last year. The comparative values were restated as to comply with the accounting policy changes of the current year.
