The Quarterly Report for the 1st Quarter of the 2016 financial year comprises :

The main results

Within the three month period ended on March 31st, 2016, SNN registered a net profit of **66.861 mii lei** (+89% y/y) and EBITDA registered an increase of **22**% compared to the same period of the previous year.
