Notification regarding the litigation initiated by Greenpeace CEE Romania Foundation and the Bankwatch Association Romania against the Ministry of Environment, Waters and Forests, the Romanian Government and SN Nuclearelectrica SA

Societatea Nationala Nuclearelectrica S.A. (“SNN”) informs the shareholders and investors that the plaintiffs Greenpeace CEE Romania Foundation and the Bankwatch Association Romania filed a summoning to trial against the Ministry of Environment, Waters and Forests, the Romanian Government and SNN, in the file no. 3793/2/2013, on the annulment, by means of administrative litigation, of the decision to issue the Environment Agreement and the GO 736/2013 regarding the issuance of the Environment Agreement for the « Continuation of the construction and completion works at Cernavoda NPP Units 3 and 4 » project.

Bucharest Court of Appeal rejected, on the merits of the case, the request of the plaintiffs. Greenpeace CEE Romania Foundation and the Bankwatch Association Romania filed an appeal, requesting the cassation of the ruling and the retrial of the case, by applying the expertise evidence.

The High Court of Cassation and Justice pronounced itself in the appeal by the ruling no. **2100** of **23.06.2016** and admitted the appeal filed by Greenpeace CEE Romania Foundation and the Bankwatch Association Romania against the ruling no. 1436 of May 9th 2014 of the Bucharest Court of Appeal – Division VIII administrative and fiscal litigations, also deciding the cassation of the attacked sentence and the sending to retrial of the case at the same court of law.
