Important event to be reported:

The prosecutors of the National Anticorruption Directorate – Constanta County Department send to trial the former managers and other persons from Cernavoda NPP

SN Nuclearelectrica SA (“SNN”) informs the shareholders and investors that the prosecutors of the National Anticorruption Directorate – Constanta County Department have ruled the arraignment of the former managers of Cernavoda NPP, under judicial control and of other 3 persons from Cernavoda NPP, with no preventive measures issued against them.

In this context, following the arraignment ruled by the National Anticorruption Directorate – Constanta County Department, on 16.03.2016, the file no. 1794/118/2016 was registered with Constanta Court of Law, in which SNN has the capacity of “injured party”, the value of the prejudice being of 3.471.463 Euro.

We underline the fact that SNN, as injured party, will take all necessary measures to protect the company's rights and interests.

The arraignment occurs following an investigation of the Anticorruption Directorate – Constanta County Department at Cernavoda NPP and the ascertainment of actions or inactions regarding the awarding of a framework-agreement of physical protection and monitoring services of Cernavoda NPP concluded in 2008, the conclusions of the investigation referring to the eluding of the public procurement specific legislation and also of the special legislation in the field of concluding and unfolding of contracts that require special authorizations on behalf of the National Registry Office for Classified Information (ORNISS).

In order to ensure the continuity of activities, the management of SNN decided, on 19.02.2016, that Mr. Marian Serban, Manager of Cernavoda NPP, overtakes the position of Cernavoda NPP Subsidiary Manager and Mrs. Titina Holobiuc overtakes the position of Economic Manager within Cernavoda NPP Subsidiary.
