- The assembly of the GEMS for 24.08.2017 by posting the convener in the Official Gazette no. 2544/21.07.2017,
- the provisions of art. 117<sup>1</sup> paragraph 1 of the Law no. 31/1990 of the companies, republished, with subsequent amendments and additions, corroborated with the provisions of art. 92 paragraph (3) of the Law no. 24/2017 related to the issuance of financial instruments and market operations and art. 14 of the Company's Articles of Incorporation,
- the provisions of the GEO 109/2011 regarding the corporate governance of public companies, with subsequent amendments and additions,
- the provisions of art. 13 paragraph (3) letter n) of the Articles of Incorporation of SNN SA,
