## Request from the minority shareholder, Fondul Proprietatea SA, for the amendment of the agenda of the Ordinary General Meeting of SNN Shareholders on 23.04.2019

Societatea Nationala Nuclearelectrica S.A. ("SNN") informs the shareholders and investors that, on **05.04.2019**, it received a request for the amendment of the agenda of the Ordinary General Meeting of SNN Shareholders scheduled for 23.04.2019/24.04.2019 from the minority shareholder, Fondul Proprietatea SA, as follows:

#### **Request to introduce on the agenda of the Ordinary General Meeting of Shareholders summoned for 23(24).04.2019** item 5<sup>1</sup>, namely:

The approval to distribute the amount of 438.625.752 lei as supplementary dividends, respectively the value of the gross supplementary dividend per share in amount 1,45474494 lei. The supplementary dividends due to the shareholders will be paid on the same date, namely June 28, 2019 and under the same methods of payment as the dividends related to the net profit of the financial year 2018.

The request is made by Fondul Proprietatea SA in compliance with the conditions provided by art.  $117^1$ , paragraph (1) of the companies' Law no. 31/1990, with the subsequent amendments, corroborated with the provisions of art. 92 paragraph (3) of the Law no. 24/2017 regarding issuers of financial instruments and market operations and those of art. 14 of the SNN Articles of Incorporation, registered at SNN with no. 4200/05.04.2019, in its quality of shareholder that owns more than 5% of the share capital of the company, regarding the introduction of a supplementary item on the agenda of the Ordinary Meeting of Shareholders dated 23/24.04.2019, namely item 5<sup>1</sup>.
