    - b) The economic operators must prove the fact that, within the previous 3 years, they have provided similar consulting services from the perspective of the complexity, within one or more contracts concluded for the same scope, for an investment project of at least 200 million Euro, including the drafting of recommendations regarding the structuring of the project and of the commercial and financing strategy. The economic operators will present proof that they have within the project team at least 1 expert with similar experience proven within at least two similar projects to the one referred in this invitation
