

NATIONAL SOCIETY "NUCLEARELECTRICA" MANAGEMENT SYSTEM POLICY STATEMENT

The nuclear safety general objective is to minimize the risks associated with exposure to ionizing radiation for the personnel who carry out professional activities on SNN subunits sites, population and the environment and is put into practice by implementing the nuclear safety principles set, which is the basis for the performance of all activities in the organization.

Being aware of the fact that nuclear safety has overriding priority over any other requirements, considerations and interests, we have decided to develop and implement a Management System that treats in a coherent, coordinated and unitary manner the components related to nuclear safety, protection against ionizing radiation, environmental protection, quality, industrial safety, physical protection, protection against cyber threats, nuclear safeguards control, classified information protection, emergency planning and response, valorization of the electricity produced and economic related aspects performance and that ensures that their requirements are not addressed separately from nuclear safety.

As SNN SA CEO, I take full responsibility for the Management System establishing, implementing, maintenance and improvement in accordance with the legal requirements and the CNCAN Norms for Management Systems in the nuclear field, integrating also the requirements from voluntary management systems standards (ISO 9001:2015 and ISO 45001:2018) and the excellence standards from the global nuclear industry.

At the same time, I commit to undertake the necessary measures for:

- Establishing and complying with policies, principles and objectives related to quality, environment, industrial safety, physical protection, cyber security, protection against ionizing radiation, emergency planning and response, information protection and economic aspects with the ultimate goal of ensuring nuclear safety
- Ensuring the necessary resources and infrastructure for the Management System development, implementation, evaluation, maintenance and continuous improvement on the terms and under the necessary conditions;
- Nuclear safety culture promotion at all levels as well as behavioral models, values and beliefs that lead to the continuous development of a solid organizational culture and continuous improvement;
- Stakeholders requirements identification and respecting and compliance with the legal and regulatory requirements applicable to the activities carried out in the organization;
- Minimizing the negative impacts on the environment, preventing pollution and improving environmental performance;
- Increasing the entire personnel awareness, motivation and involvement by recognizing their contribution to organization's performance improvement, to policy and objectives achievement in all departments.

- Ensuring the adequate working conditions for carrying out activities through the permanent control of risks regarding industrial safety and establishing measures to eliminate hazards and prevent occupational injuries and illnesses.
- Ensuring the conditions for workers the consultation and participation regarding aspects related to industrial safety.

The Management System provisions application is mandatory at all management and execution levels from the entire organization.

The present policy statement implemented and maintained within the organization is binding, being communicated to all SNN SA personnel and verified through the periodic management system review carried out by the highest level management.
